Dear Friends of Oliver,

What a difference a year makes! Thanks to the enormous support of our donors, 2016 was a pivotal year of growth for Oliver Scholars. We both expanded our capacity to serve students and increased the programs we offer to change the ratio of access and opportunity for African-American and Latino students from low-income communities.

We were very excited to launch a new program that prepares 4th and 5th graders to enter independent middle schools. This year we laid the groundwork for academically gifted younger scholars to receive the same style of rigorous pre-placement preparation and support that their older counterparts have had for the past 33 years. This is a tremendous opportunity to intervene at an earlier age and shift the trajectory toward academic achievement sharply upward. The first cohort will be admitted in spring 2017.

We also augmented our ongoing programs with:

- New pre-placement services on biotechnology and leadership
- More robust post-placement support through tutoring, counseling support, and workshops on test anxiety and financial literacy, among other topics
- Greater concentration on college and career with more college tours, SAT/ACT prep and on-campus visits to students once they have matriculated

Much of the success in 2016 was made possible by our donors. We were fortunate to receive an especially generous grant of \$30 million over 3 years from an anonymous donor that allowed us to be bold and ambitious with program expansion, with a corresponding growth of staff to 25.

Likewise, we were grateful for the many opportunities to embrace Oliver's extended community of donors, alumni, supporters, and friends, and to give thanks for your continued belief in our work.

- At our 3rd Annual Gala, we honored past Board Chair Judith-Ann Corrente as a longtime ally and true Oliver Champion
- Our Junior Board came together for its inaugural Soirée for Scholars in the fall
- The Alumni Council gave back through mentorship, donations, and volunteering at Oliver events

As we look to the future, Oliver Scholars is well-positioned to build on the success of 2016. Our students continue to demonstrate that they are more than ready to excel at highly regarded academic institutions. Our community of supporters is steadfast in doing what it takes to generate greater equity for high-achieving students and their families. And our staff works daily to connect with more students through programs that are substantial and sustaining.





OUTREACH & RECRUITMENT

We identify talented and motivated students who will make the most of the Oliver opportunity through outreach and recruitment, which runs virtually year-round. In 2016, we invited nominations for high-achieving African-American and Latino 7th graders from throughout the five boroughs of New York. Beginning in spring 2017, we will invite nominations of 4th graders from Districts 4, 5, 6, and 7 as well.



SCHOLAR IMMERSION & PLACEMENT (SIP)

This 14-month pre-placement services program is the starting point for preparing our scholars for the rigor and opportunity they will encounter at top independent schools. Across its 33-year history, Oliver has equipped 7th and 8th grade students to apply to, and enroll in, top independent high schools.

Outreach for nominations begins in the fall. Accepted students attend five-week intensives each summer that include academic enrichment, SSAT preparation, and support with the independent school application process. One week of each cycle takes place at a boarding school. During each school year, students take on an exacting weekly schedule of academic and leadership training.

FOURTH GRADE ENTRY (New this year)

Recruitment began in 2016, and students will come on board in spring 2017. Key programming will cover academic enrichment (Math, History, English, and Science), SSAT preparation, and support with the Independent School Application process.

- Summer Program 1 (summer after 4th grade)
- Fall and spring pre-placement services
- Summer Program 2 (summer after 5th grade)
- Placement into independent school for 6th grade




SEVENTH GRADE ENTRY

Weekly academic classes, along with preparation for SSAT, and interviews and applications to independent schools.

- Summer Program 1 (summer after 7th grade)
- Fall and spring pre-placement services
- Summer Program 2 (summer after 8th grade)
- Placement into independent school for 9th grade

New this year:

- STEM, with a focus on biotechnology
- Musical Theater
- Emerging Leaders, an experiential course designed by Oliver Scholars' CEO David Allyn, PhD., to increase students' capacity for "The Three P's": perspective-taking, public speaking, and persistence.



GUIDANCE PROGRAM FOR SCHOLARS (GPS)

Post-placement, Oliver remains tightly connected to scholars. Transitioning students are supported through regular visits with our counselors as well a growing mentorship program and ongoing events such as our Tuesday Talks and annual Leadership Conference, In Our Own Voices.

New this year:

Tutoring



- Leadership retreat
- Support from Social Worker and Learning Specialist
- Seminars in test anxiety, eating disorders, substance abuse prevention, and financial literacy

COLLEGE AND CAREER SERVICES (CCS)

This year, Oliver Scholars expanded programming to better position scholars to succeed as they transition to college and career. New or expanded supports include:

- College tours (21 schools in 2 weeks)
- One-on-one college counseling
- SAT and ACT prep
- Career Bootcamp
- College Freshman Forum
- Financial aid workshops
- College panels
- On-campus visits to college freshmen by Oliver staff

The third annual Oliver Scholars Gala drew the largest crowd yet! Two hundred and seventy guests joined us on May 18th as Past Board Chair Judith-Ann Corrente received the Champion of Excellence Award for her tireless support of Oliver and educational access. Host and Oliver Alumna Marysol Castro ('92) honored our 2016 graduating class, and presented awards for excellence in Scholarship, Leadership, and Service to seniors Deric Rollins (Hotchkiss '16, Cornell '20), Daria Forde (Miss Porter's '16, Barnard '20), and Juan Otoya Vanini (Columbia Grammar and Preparatory School '16, Yale '20), each of whom also received a generous scholarship sponsored by Dior. The evening raised almost \$500,000 and culminated with the announcement of an extraordinary \$30 million gift that will allow Oliver Scholars to double the number of scholars over the next 10 years. This ushers in a new era for Oliver — and for all high-achieving, low-income students of color in New York City.




